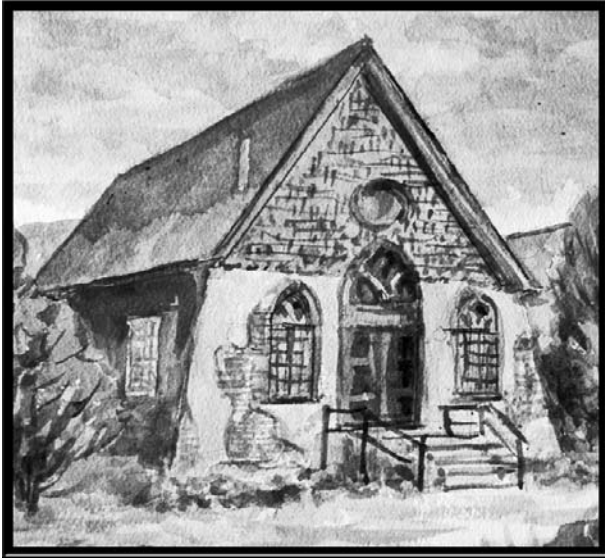

Grant County Art Guild Business Meeting, August 13, 2010

The meeting was called to order at 3:00 p.m. by Lois DeLong, in absence of the President and Vice President.

The minutes of the previous meeting on Aug. 11th, were presented in the newsletter. Jeanne Dickerson moved and Barbara Kejr seconded a motion to approve the minutes. Accepted.

The Treasurers report was submitted by treasurer, Lois DeLong. Previous balance \$1,171.50
Current expenses \$592.38, and receipts of \$300.00 was deposited for 5 memberships, leaving a balance of \$879.12. The treasurer's report was accepted as presented.
